1. Invitation of Tender

Tender Invites from the agency for the supply of Camera under buyback for the use of HO.

GENERAL INSTRUCTIONS

1. **Submission of Tender:** - Tenders are to be submitted post/courier/by hand to MRCMPU Ltd., Milma Head office, Peringolam, Kunnamangalam.
2. **BID Currencies:** Prices shall be expressed in the Indian Rupee only.
3. **Documents to be Submitted in Cover I**
 - Tender Fee Rs.500/-, Earnest money of Rs.5,500/- (Attached copy of payment receipt if directly paid at MRCMPU head office, if document downloaded from website) **in favour of The Managing Director, MRCMPU Ltd., Milma Head office, Peringolam, Calicut – 673571.**
 - GST Registration number.
 - Technical document with every page of tender should be signed & sealed by the tenderer.
 - **Experience:** The bidder shall have **at least 3 years of experience** in supplying photography cameras or similar professional photographic equipment to Government Departments, PSUs, Co-operative institutions, or reputed organizations.
 - **GST Registration:** The bidder shall possess a valid **GST registration** and shall submit the GST certificate along with the bid.
 - **Non-Blacklisting:** The bidder shall submit a declaration that the firm/OEM has **not been blacklisted or debarred** by any Central/State Government Department, PSU, statutory body, or other Government institution.
 - **Product Compliance:** The bidder shall submit the **technical datasheet/catalogue** of the quoted model clearly establishing compliance with all tender specifications.
 - **Price:** The quoted price shall include **camera body, lens, battery, charger, memory card, carrying case and all other accessories** required for normal operation, unless specifically excluded in the tender.

1. **Documents submitted in Cover II as Separate Cover**

- a. Form –1 duly filled, sealed and signed.

Tenderers alone will be responsible for the submission of defective tenders and such tenders are liable to be summarily rejected

2. **Opening of Tenders:** - The tenders will be opened on the date and time of opening, as notified.
3. The Malabar Regional Cooperative Milk Producers' Union Ltd., is not bound to accept the lowest price bid offer. Managing Director (MRCMPU Ltd.) has the absolute right to reject any or all the tenders without assigning any reason thereof.
4. Unless accepted in writing, the conditions of the tender document will be valid and no extension of time for submission of tenders will be granted on any account.
5. The tenderers have to comply with all the statutory requirements in respect of the tender submitted by them.

6. The language of the tender should be in English and the corrections, if any, should be attested under seal with full signature.
7. Only the authorized signatory should submit the tender. **Power of Attorney authorizing the person to sign all the documents pertaining to this tender shall be submitted in Cover I.**
8. At any time prior to the deadline for the submission of tenders, Malabar Regional Co-operative Milk Producers Union Ltd may, for any reason, whether at its own initiative or in response to a clarification requested by any prospective tenderer, may modify the tender documents by amendments and in such an event, it shall be binding on all tenderers who have submitted the tenders.
9. The obligation of the successful tenderer Company/Firm under this contract shall not cease even if the ownership changes. The successor in interest or transferee shall be bound by the provisions of the contract.
10. Purchase order shall be issued on the lowest responsive bidder.
11. **Taxes:-** The percentage of taxes and duties quoted in the tender, if any, should be indicated clearly. During the currency of the service period, the price shall remain firm, however, any increase in statutory levies shall be paid on the production of documentary evidence and similarly in case of a decrease in levies suitable adjustments shall be made while effecting payment. The price quoted should be inclusive of all taxes duties etc. which are or may become payable by the successful tenderer under existing or future laws or services during the course of executions of the contract. It will be assumed that the prices quoted are inclusive of all such taxes duties etc. and extra claims therefore will not be accepted. The successful tenderer has to bear all the statutory taxes. MRCMPU Ltd will make necessary deductions from the payment and issue a certificate to that effect.
12. **Payment:** 100 % of the total invoice value shall be paid within 20 days after the supply of the items.
13. The rate quoted will be considered firm for acceptance till three months from the date of opening of the bid. If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money deposited by him will stand forfeited to MRCMPU Ltd.
14. Tenders not stipulating the period of firmness of price and tenders with price variation clause and or “subject to prior sale” conditions are liable to be summarily rejected.
15. Tenders submitted subject to conditions will not be considered. They are liable to be summarily rejected on that sole ground, and the EMD will be forfeited.
16. The final acceptance of the tender’s rests entirely with the Managing Director, MRCMPU Ltd., who does not bind himself to accept the lower or any bid. But the tenderers on their part should be prepared to carry out the work as per the work order allotted to them. In any case, the decision of the Managing Director, MRCMPU Ltd., shall be final and no correspondence shall be entered into, as to why a tender was not accepted.
17. No representations for enhancement of rate once accepted will be considered.

18. Any attempt on the part of the tenderers or their agents to influence MRCMPU Ltd. In their favour by personal canvassing will disqualify the tenderers.
19. Special conditions, if any, mentioned in the quotation of the tenderer or in any other communication from the tenderer will not apply to the contract unless they are expressly accepted in writing by the purchaser.
20. The successful tenderer is not liable for problems arising out of breakdown or service or spares costs arising out of damages caused due to fire, theft, riots, accidents, earthquakes, storms, lightning and other natural calamities.
21. The tender value will be evaluated against the items quoted altogether.
22. The tenderer should quote all the items in Form -1 else the tender will be treated as cancelled.
23. Bidder shall not sub-contract or permit anyone other than the company personnel to perform any of the services required by the Bidder. Services need to be provided only by the bidder.
24. Upon receipt of notice from the department for defective material, the Contractor shall within 7 days of receipt of the notice, replace the defective material, free of cost at the destination.
25. Discounted offers should be mentioned clearly in the financial bid only.
26. The item to be delivered and installed at our office building situated at MRCMPU Ltd, Head office, Peringolam, Kunnamangalam PO, Calicut-673571.
27. The Contract cost shall be final and binding. No price escalation shall be entertained by the Client on any account whatsoever
28. **Force Majeure:** The successful tenderer shall not be liable or deemed to be default of any delay or failure in performance stated herein resulting directly or indirectly from causes beyond his reasonable control. If the successful tenderer is prevented from performing their function due to fire, theft, earthquake, flood, accidents, riots, natural calamities, etc., the successful tenderer's liability ceases. Then both the parties shall discuss the course of action to be taken afterwards.
29. **Jurisdiction:** The court situated in Kozhikode City alone will have jurisdiction with regard to the Contract.
